Screenwriting Competition Rules.

1. Open to residents of Washington County, Kane County, Iron County and the City of Mesquite who have not had a screenplay produced.
2. The action must be set in the above areas in legally accessible locations.
3. The story must be set in the present day.
4. The story must not require stunts or situations that would put the actors or crew at risk.
5. The maximum running time is 20 minutes plus titles and credits.
6. The maximum number of characters is five adults (no children).
7. The closing date is for entries post marked April 1st 2010.
8. The writer must have clear title to the copyright and must not infringe the rights of others.

Judging and Production.

9. The winning screenplay will be selected by a panel of judges nominated by TSB.
10. TSB will produce the winning screenplay on HDV video at TSB cost.
11. The copyright in the screenplay will be retained by the writer but entry into the competition confers on TSB the right to produce the movie at their cost and enter into appropriate film & video competitions and festivals for one year after completion, in consultation with the writer, as a TSB production. The writer will receive full credit as Writer and Associate Producer. Copies will be available to the cast, crew and members of TSB.
12. TSB will have no rights in any further commercialization or distribution of the film beyond those outlined above.
13. The judges decisions are final and binding on both the entrants and TSB.
